Dear PPCR Sub-Committee members,

Please find attached a request for a Project Preparation Grant to prepare the investment project for *Building Climate Resilience in Pyanj River Basin*. This proposal, which has been submitted by the Government of Tajikistan and the Asian Development Bank, is requesting USD 750,000 in PPCR funding for project preparation. The proposed project is included in the Strategic Program for Climate Resilience for Tajikistan, which was endorsed by the PPCR Sub-Committee in November 2010. As supplementary documentation, the ADB submitted also the concept paper for the project, which is informing the preparation grant request.

The Trust Fund Committee is requested to approve the following decision:

**The PPCR Sub-Committee approves USD 750,000 in PPCR funding to contribute to the preparation of the project, *Building Climate Resilience in Pyanj River Basin* (ADB) as part of the Strategic Program for Climate Resilience for Tajikistan.**

The Trustee has confirmed that there are sufficient resources available for commitment of the resources requested for this project preparation grant.
