PPCR ROSTER OF EXPERTS

Proposed Decision by the PPCR Sub-Committee


The Sub-Committee reviewed document PPCR/SC.10/10, *PPCR Roster of Experts*, and approves the roster. The PPCR Sub-Committee invites the Government of Haiti to select an expert from the approved roster to review its draft SPCR once it is available.

I. INTRODUCTION

- 1. In accordance with the agreed *Procedures for the Preparation of Independent Technical Review of PPCR and SREP Investment Plans*, a proposed PPCR roster of experts available to carry out independent technical reviews of PPCR investment plans was circulated to the PPCR Sub-Committee for approval in September 2011. The Sub-Committee did not agree to approve the roster, and a number of comments were received from members of the Sub-Committee emphasizing the need to seek more appropriate gender balance before the roster is approved.
- 2. During its meeting in November 2011, the PPCR Sub-Committee reiterated its request to the CIF Administrative Unit and the MDBs to undertake efforts to improve the gender balance in the proposed roster of experts, and it noted that the CIF Administrative Unit had been reviewing additional resumes of female candidates to be included in the roster.
- 3. This document presents to the Sub-Committee for its approval an expanded roster of experts with more gender balanced than the initial roster. The Sub-Committee is requested to review and approve the proposed roster.

II. PROPOSED PPCR ROSTER OF EXPERTS

- 4. The initial PPCR roster of experts proposed in September 2011 had 34 candidates, 31 of which were male and 3 were female. Over the past months, the CIF Administrative Unit, in collaboration with the MDBs, has solicited the names and resumes of female experts to be included in the roster. The MDBs identified potential candidates to include in the roster and an open call was posted on the CIF website.
- 5. As a result, 13 additional nominations were received, 10 of which are female candidates. These candidates were reviewed and cleared by the MDB Committee and included in the proposed roster attached as an annex.
- 6. The proposed roster includes 47 experts that were cleared by the MDB Committee as meeting the agreed eligibility requirements (see Annex B of the *Procedures for the Preparation of Independent Technical Reviews of PPCR and SREP Investment Plans*). The charts below show the change in gender distribution from the initial to the expanded roster:
